IMPORTANT:

THE DEPARTMENT OF DEFENSE HAS ISSUED PHASE III BUSINESS RULES FOR THE DEFENSE PERSONAL PROPERTY PROGRAM (DP3) IN THE DEFENSE TRANSPORTATION REGULATION (DTR) PART IV (DTR 4500.9R).

THE PHASE III BUSINESS RULES ENCOMPASS PROCEDURES FOR NON-TEMPORARY STORAGE (NTS), DOMESTIC SMALL SHIPMENTS (dS2), DOMESTIC LOCAL MOVE (dLM ), INTERNATIONAL LOCAL MOVES (iLM), AND INTERNATIONAL INTRA-COUNTRY MOVES (iCM).

ALL APPROVED TSPS ARE ENCOURAGED TO VIEW THE FEDERAL REGISTER NOTICE AND PROVIDE COMMENTS TO THE PHASE III BUSINESS RULES IN ACCORDANCE WITH THE GUIDANCE PROVIDED IN THE FEDERAL REGISTER NOTICE. COMMENTS MUST BE RECEIVED ON OR BEFORE 1 JUNE 2010.
